6. **Participation Method:**

a. To participate in the Promotion, purchase a minimum of Ringgit Malaysia Sixteen (RM16) ("Minimum Purchase") of any Product in a single original receipt from any instore outlet ("Receipt") and/or invoice screenshot from any online platform ("Invoice") during the Promotion Period. b. <u>Instore Outlets Receipt</u>:

- i. The Receipt can come in the form of printed receipts from point-of-sale systems and/or hand-written receipts for instore outlet purchases.  - vi. An auto reply acknowledgement message will be sent by the Organiser for the first WhatsApp Entry received from each mobile number only.

3.2 The Organiser may require a Participant to provide proof of eligibility to participate in the Promotion including without limitation, identification documents, and the written consent of parents/legal guardians in the case of Participants below the age of eighteen (18) years.
